The regular meeting of the Silver Grove City Council was held on Thursday, August 1, 2024 at the Silver Grove City Building, 308 Oak Street, Silver Grove, Kentucky 41085.

Call to Order:

 - **Eagle Scout Projects-** Trying to gather some wood poles for the project. Will look into grants to help with funding.
 - **East First Street-** The poles have been removed. Rector is almost finished with the concrete. They are required to put top soil down, grass seed and straw the yards when the project is completed.
